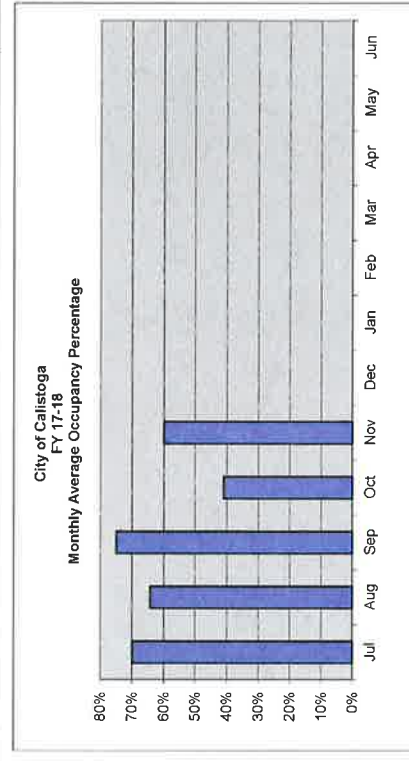
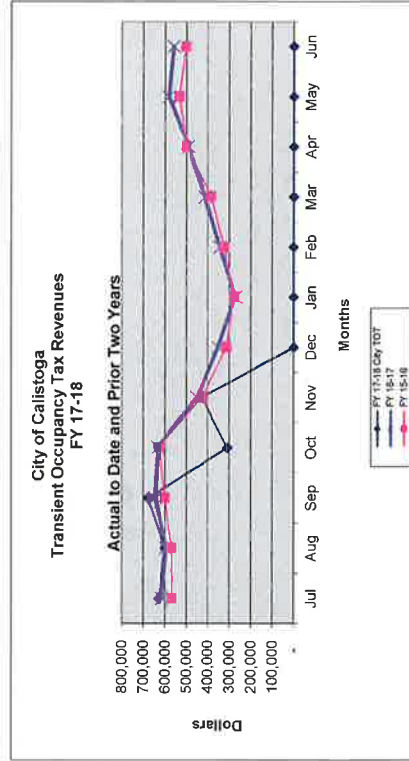

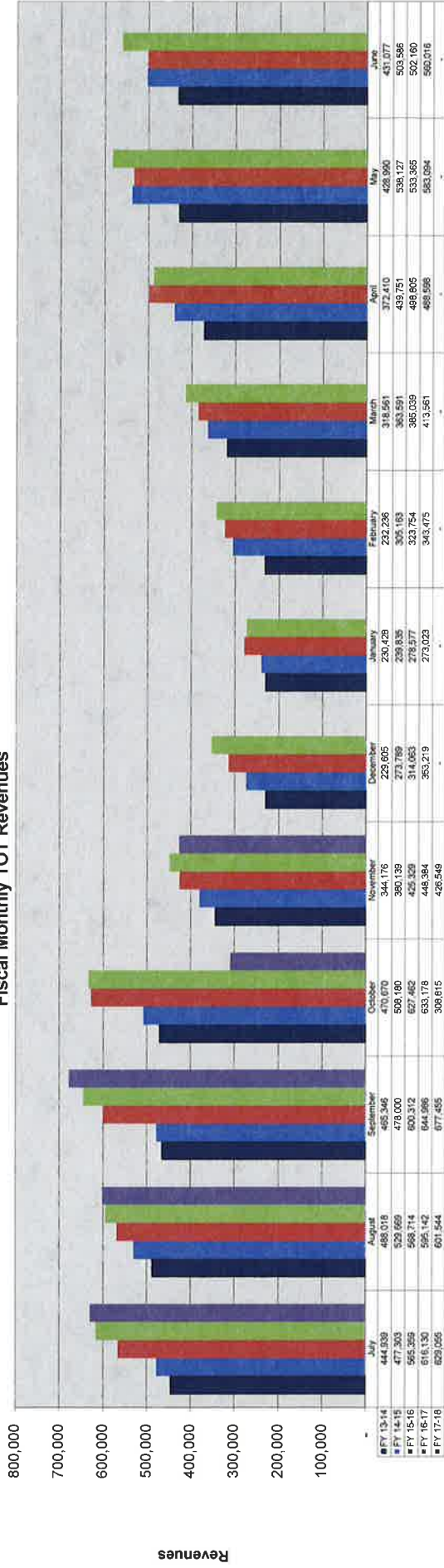

Monthly Occupancy Rates - All Types

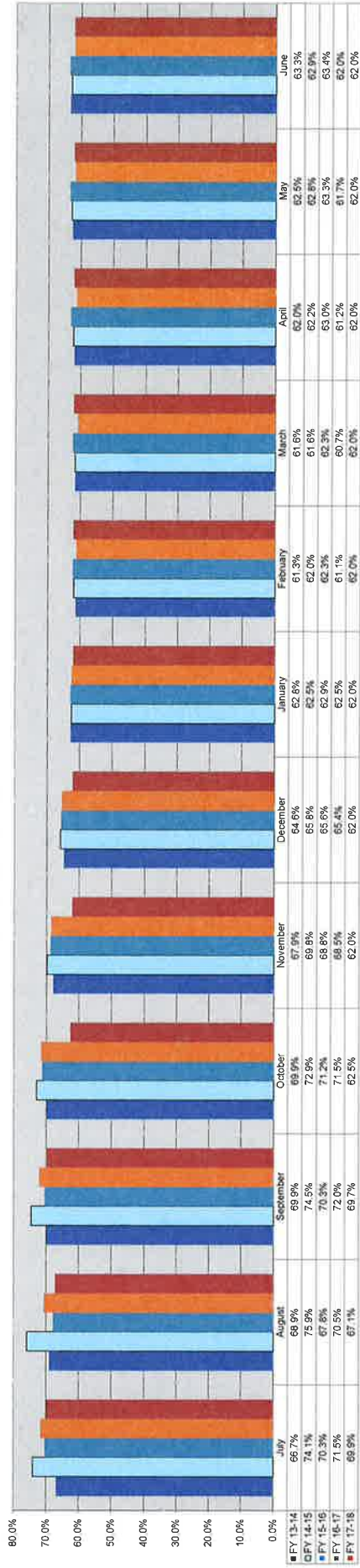
