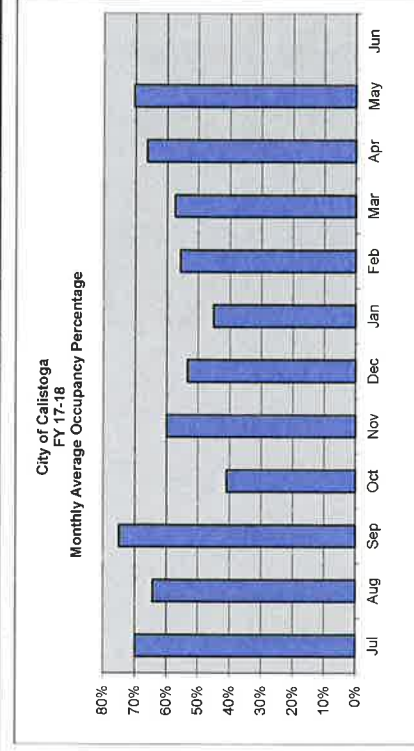
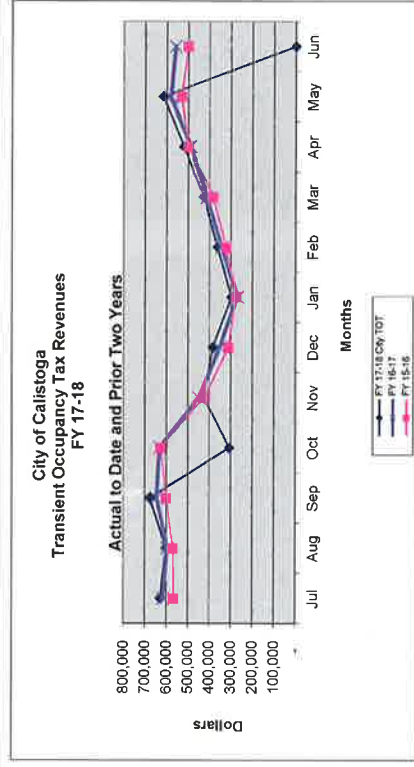

City of Calistoga Fiscal Monthly TOT Revenues

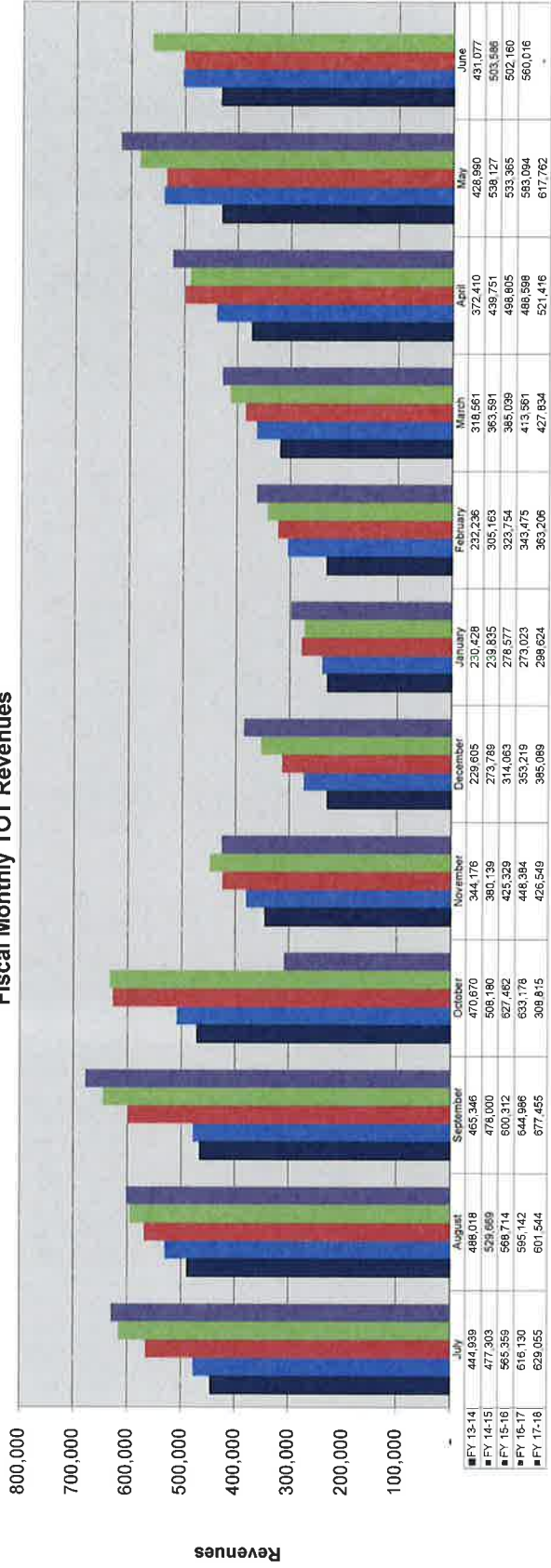

Monthly Occupancy Rates - All Types

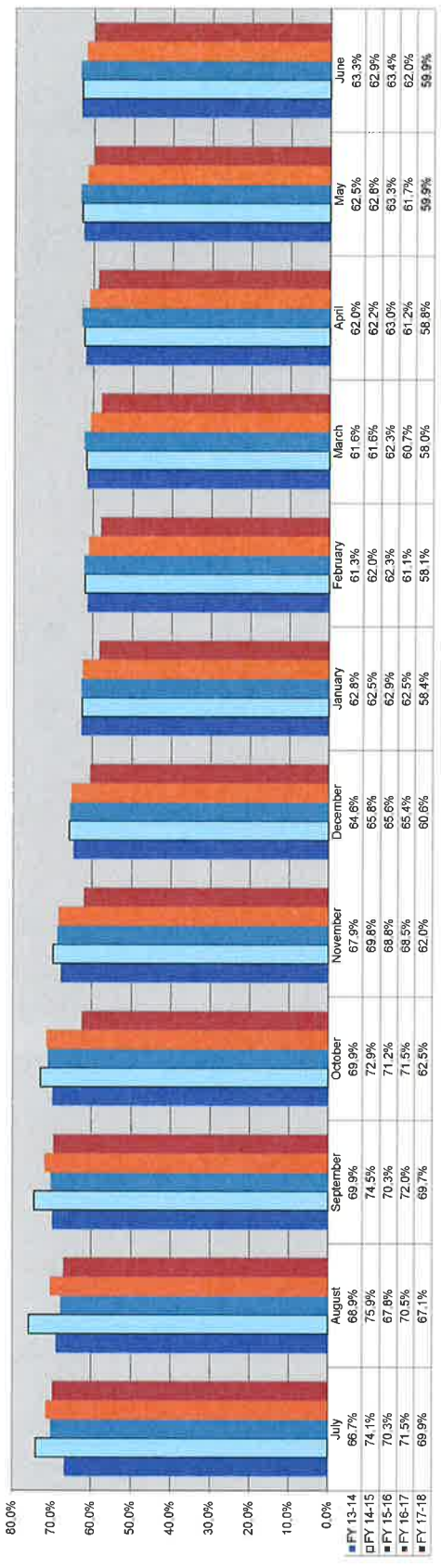
